### **NISO Regional AGMs**



## **IRISH NEWS**

### **O'Halloran and Higginson leaving HSA**

Martin O'Halloran, Chief Executive Officer, Health and Safety Authority (HSA) and Brian Higginson, Assistant Chief Executive for Operational Compliance and Prevention, HSA, have both recently announced that they will be leaving the HSA in 2018. O'Halloran is leaving due to retirement and Higginson is moving onto a new role with the Commission for Railway Regulation. National Irish Safety Organisation would like to acknowledge both Martin O'Halloran's and Brian Higginson's contribution to health and safety in Ireland and to wish them well in their future endeavours.

### **Statement of the HSA regarding first aid training**

The Health and Safety Authority (HSA) has determined, in consultation with Quality and Qualifications Ireland (QQI) and Pre Hospital Emergency Care Council (PHECC), that dual recognition of QQI 5N1207 and PHECC FAR will continue until 31st May 2018. Thereafter the HSA will only recognise PHECC FAR.

### **Top OSH prosecutions of 2017**

From million-pound plus fines to prison sentences, there have been some major prosecutions in occupational health and safety in 2017 in the UK. In the first full year where new sentencing guidelines have been in effect, fines have risen from over £35m to over £61m.

The 2018/19 campaign aims at raising awareness of the risks posed by dangerous substances in the workplace and promoting a culture of risk prevention to eliminate or effectively manage these risks.

### **Survey on risk assessments in EU countries**

The results of the ESENER-2 survey which asked "does your company regularly carry out workplace risk assessments?" are now available on the EU-OSHA website. The survey reveals that Ireland is just under the EU average for organisations carrying out risk assessments in the workplace. The EU average is 77.2% while the average in Ireland is 72.7%.

### **LEGISLATION UPDATE**

#### **European Communities (Carriage of Dangerous Goods by Road and Use of Transportable Pressure Equipment) (Amendment) (No. 3) Regulations 2017**

These Regulations give further effect to the provisions of Directive 2010/35/EC of the European Parliament and the Council on transportable pressure equipment in as much as they allocate the responsibility for the role of Notifying Authority under that Directive to the Minister for Business, Enterprise and Innovation, this responsibility having previously sat with the Health and Safety Authority.
