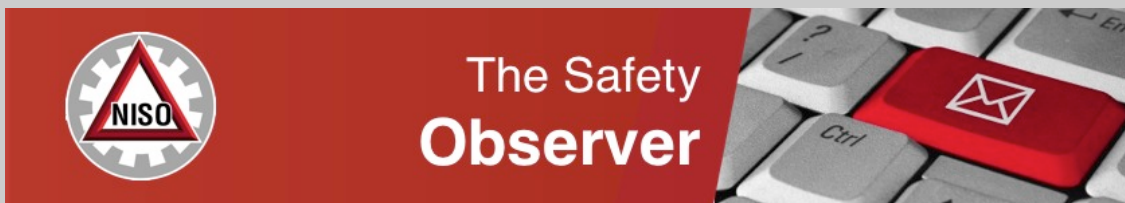

### **Farming is Ireland's "most dangerous occupation"**

The fatality rate for farmers was 10 times that of the average worker between 2009 and 2015, a trend which may be explained in part by excessive risk-taking behaviour, according to a new report.

A food manufacturing giant has been fined £2m after a worker was fatally crushed when a plastic bale weighing 700kg collapsed on him.

### **Construction firm fined £800,000 after Heathrow Airport fatality**

A construction firm has been sentenced following the death of a worker at Heathrow Airport in October 2014. The court heard that deceased brother accidentally reversed into his 38-year-old sibling when the pair were trying to move a broken down scissor lift on a service road, while working for construction firm in question.

A Health and Safety Executive (HSE) investigation found that neither worker was authorised with the appropriate certificate to use the dumper truck, and that the operation was not properly overseen or managed.

### **EU road death figures: third year of poor results**

The European Commission has published new data showing that deaths on EU roads fell by just 2% last year, following a 1% increase in 2015. According to

ETSC analysis, road deaths will now need to fall by 11.5% a year in order to meet the EU target of cutting deaths by half in the decade to 2020.

Garda and HSA Investigations were launched after the body of the pensioner, understood to be in his early 80s, was discovered near an overturned quad bike on a farm in Co Offaly.

### **Worker sustains injuries setting up funfair**

A man was injured while unloading a vehicle used to transport rollercoaster equipment on the funfair site when it is understood that a piece of metal track became dislodged and was struck by the falling beam.

Garda technical experts sealed off the incident site for a forensic examination and an inspector from the Health and Safety Authority (HSA) also visited the scene.

### **Co. Meath firm fined €1m over workplace fatality**

A Co. Meath concrete firm had a fine of €125,000 quashed and a new fine of €1m imposed following the death of a worker in 2011 which was caused by a deliberate breach of safety procedures.

### **Limerick steelworker awarded €675,116 following accident**

A Limerick steelworker who suffered "near fatal" and severe personal injuries



has been awarded €675,116 at the High Court. The accident happened as the injured party was moving a jig from a dryer. The jig suddenly became detached from one of the hooks on the crane and struck the plaintiff, pinning him between the jig and the barrier. The court heard that he suffered near fatal and severe personal injuries, loss, damage and expense.

### **Haulage company fined after RSA investigation**

Following an investigation by the Road Safety Authority (RSA), a large Co. Louth haulage company was before the District Court in April 2017. The company, who operate a road transport business, pleaded guilty to a series of charges for failing to produce driver's hours records in respect of several vehicles operated by the company.

### **Deli worker awarded €65k following ligament tear**

An assistant chef who hurt her shoulder and ankle while working in the deli at a branch of a national supermarket chain has been awarded €65,000 by the High Court. The plaintiff suffered a jerking injury to her left shoulder and a partial tear of a ligament in her ankle joint when she attempted to catch a piece of deli counter glass which was falling to the ground after she washed it.

An airport worker, who was injured when a mini avalanche of snow and ice fell on his head from the curved roof of the new Terminal 2 seven years ago, has settled a €60,000 damages claim.

### **Hotel worker awarded €77k after cutting hand**

A hotel worker who cut his hand on a piece of glass while gathering up till receipts was awarded over €77,000 by the High Court. The plaintiff suffered a fairly serious injury and has been left with a zig zag scar on his left ring finger. He also now had a decreased grip on his left hand as a result of the accident. The plaintiff claimed there was a failure to have a safe system of work in or about the disposal of broken glass and till receipts and that a hazard or trap

had been created at the cash register.

## **INQUESTS**

### **Man was crushed to death beneath 40 tonnes of cheese, inquest hears**

A 32-year-old man died after he was crushed beneath forty tonnes of cheese in a workplace accident, an inquest has heard. The deceased suffered catastrophic crush injuries when a shelf rack collapsed at a cold storage warehouse where he worked. The accident happened in a cold store-room in north Dublin.

An inquest into the death of a 29-year-old man who died while clearing trees for the construction of a wind farm in Donegal recorded a unanimous verdict of death by misadventure. The jury concluded that the cause of death was traumatic/mechanical asphyxia and the compression of his chest by a fallen tree.
